**(From Patricia Williams, Security Task Force Chair):** On Monday, January 22, Major Jacob Montgomery from S.E.A.L. (Strategic Executive and Logistical Security Solutions) provided the Shepherd Forest Security Task Force with a colorful booklet that explained their Community Patrol Program, and he expanded on the details during our meeting. S.E.A.L. currently serves Timbergrove. Here are a few benefits mentioned during the meeting.

- 24 hour hotline exclusive to Shepherd Forest;
- An officer would work 40 hours per week;
- Marked security car with K-9 included; and
- Authority to arrest but not transport, would coordinate with HPD.

Our next Shepherd Forest Security Task Force meeting will be held **on Monday, February 26, from 7:00 p.m. until 8:15 p.m. at the YMCA, located at 1234 West 34<sup>th</sup> Street.** Captain Hennessy, Lt. Alfred, and Chief Harrison from the Constable's Office will be our speakers. That office staff currently serves Garden Oaks and Shepherd Park Plaza. All SF residents and owners are welcome to attend and join the Task Force.

In addition, we discussed the Citizens on Patrol Program (COP) at both the last task force and board meetings. If you are interested in attending the one- hour-thirty-minute training session and volunteering to patrol in your section, you may sign up at either the Civic Club social on February 19 or the Task Force meeting on February 26.

# Spring Comes Early to White Oak Bayou

If the banks of the bayou along East T.C. Jester at 34<sup>th</sup> seems a little greener these days, its not just because of all the rain we've had recently. Within the past week, 50 new young trees were planted there by volunteers from **Coca-Cola Southwest** and **Trees for Houston**, partnered with the **Houston Parks Board**. This was part of the Bayou Greenways 2020 initiative, dedicated to beautifying the area's bayous.

According to *The Leader* Newspaper, Trees For Houston Executive Director Barry Ward said "They're going to create shade and cool this entire area down, so this cement will last longer due to the shade and cooling effect; plus, all of this will be much nicer, and easier for people to use."

In addition to providing volunteers, Coca-Cola made a generous \$10,000 donation to assist in the purchase, planting and future upkeep of the area
